<b>4. Key dates</b>	Entries open at 8am AEST 18 <sup>th</sup> March 2019 with the Major Draw Night 29 <sup>th</sup> May 2019 ( <b>Entry Period</b> ).
<b>5. Notification of Invitee</b>	<p>(a) The Promoter will contact the Invitee by phone within 2 days of the Invitation Draw by using the contact details registered on the system.</p> <p>(b) If, for any reason, the Promoter is unable to make contact with the Invitee within 7 days of the Invitation Draw, another Invitee may be drawn on the same terms and conditions as the original Invitation Draw. This process will continue until the Promoter is able to contact an Invitee. All other envelopes (99) will contain a message stating that they represent a Free AIPP Photographers Insurance package to the value of AU\$1,000 (<b>Minor Prize</b>).</li> </ul> <p>(e) The Invitee may select one envelope from the barrel.</p> <p>(f) The Invitee will have one chance to select an envelope.
